### **Getting Started**

1. Plug the Power Supply into HiRise 3 Deluxe and your Power Supply in a wall outlet

Note: Apple Watch Charger can be lifted upright or kept flat for your preferred charging position or to accommodate certain Apple Watch Bands

### **Charging your Devices**

HiRise 3 Deluxe is more flexible than you think, see below to learn all the different devices you can charge with HiRise.

5W wireless charger compatible with AirPods or a second wireless charging phone

15W Qi2 magnetic charger for iPhones, Qi2 mobile phones or compatible AirPods

Apple Watch fast charger works with all Apple Watch models including Ultra
