Bring a Successful Stick Mobility program to your facility!

Looking for a way to differentiate your facility? Host a Stick Mobility Course to get your team the education they need – along with valuable CECs – with a versatile and functional piece of fitness equipment. You provide the facility and the participants, Stick Mobility will take care of the rest.

What are the course benefits?

- Expert instruction for up to 20 participants.
- Convenient location your facility or another facility arranged by you.
- A Digital Course Manual for each student; lifetime access to 14 hours of course content
- CEC offerings from major accrediting organizations
- Discounts on products
- Course logistics and administration are handled by Stick Mobility

Where will the course be held?

- Generally, at your facility, although some customers have arranged for courses to be held at third-party sites.
- To qualify, a facility must:
 - Have Stick Mobility product bundles for each participant, purchased by host or attendee. (See below for more details)
 - Be able to accommodate 20 or more participants comfortably
 - Offer a space that is quiet, comfortable and conducive to learning
 - Be available for approximately nine continuous hours (e.g., 8:00am-5:00pm) and two consecutive days

Where do people sign up?

That's entirely up to you. Once you have paid for the course, you have up to 20 slots to offer. Just give Stick Mobility an attendance roster with each participant's full name and email one week before the course date.

Who provides the course materials?

Stick Mobility will provide access to digital course manuals, communications, liability waivers, videos, exams, and certificates of completion all through the Learning Management System.

What does the course include?

- Two-day training for up to 20 students
- Course resources
- Special product rates
- Certificate of Completion and CECs
- Expert instruction
- Course logistics and administration

Besides arranging the room and signing up participants, what else will I need to do?

- Send the course roster to: info@stickmobility.com one week before the course.
- Share your experience with others

What does it cost?

There are three tier options payable within 30 days of course dates confirmation.

- 1. \$4,000 up to 12 participants
- 2. \$6,500 for 13-16 participants
- 3. \$8,500 for 17-20 participants

How do participants get their Training Sticks?

- The Host can purchase Training Stick Bundles at the sliding scale discounted rates per tier - 30% off (up to 12 participants), 35% off (13-16 participants), 40% off (17-20 participants).
- 2. The attendee must purchase or bring their Training Stick bundle to the course. If participants need to purchase a Training Stick bundle, Stick Mobility will provide a discount code for 20% off and attendees can have the product shipped directly to them or to the facility by entering the shipping address in the checkout.

- Execute the course contract (see below), confirm the date and pay the course fee.
- Get an attendance roster to Stick Mobility one week before the course date.

Host Facility Agreement

Facility. [FACILITY NAME] ("Facility") will permit Stick Mobility exclusive use of a room at [FACILITY NAME AND ADDRESS] (the "Room") from 8:00am to 5:30pm on [DATES] for the purpose of holding a [COURSE]. The Room is approximately [SQUARE FOOTAGE] square feet in size and will have enough space to comfortably accommodate the students taking the course, with all Training Sticks being in use at once. (Note that there will be one Training Stick bundle for every student.

Course Fee. Facility will pay Stick Mobility based on the chosen tier within five business days of the date of this agreement. Facility will identify up to 20 attendees and provide Stick Mobility with each participant's full name and email at least one week before the course date.

Indemnification. Stick Mobility and Facility will each indemnify the other against any loss, cost or damage (including reasonable attorneys fees, costs of suit, damage awards or settlement) (each a "Covered Expense") arising from any (i) injury suffered during the course by a student or instructor or (ii) damage to the facility that is caused by the indemnifying party's negligence, recklessness or willful misconduct (each an "Indemnification Event"). To be a Covered Expense, the settlement of any claim must be approved by the Indemnifying Party in writing.
