



STEALTH COLD PLUNGE

INSTALLATION GUIDE



*Please note that this manual is for the Plunge Tub only.
The User's Manual for the Chiller is separate and will be included with the optional Chiller.*

Installation

1.1 Installation Site Requirements

Place the tub on a flat, stable surface that can bear the full weight of the tub when filled with water and a person inside. Inadequate structural support may result in personal or property damage.

Only install your cold plunge tub on a waterproof floor to prevent water damage to your surroundings. Failure to do so may result in property damage.

Install the unit in a safe location that is not easily accessible to children. Ensure that the unit is out of their reach and properly secured to prevent unauthorized access.

Please ensure that the installation site provides easy access to a water source and water drainage, and is waterproof. Adequate water access is necessary for filling and maintaining your cold plunge.

Important Tips:

The ground should be smooth and flat, and there should be no sharp objects. Users should also consider the total weight of the user, tub, and water to ensure that the ground has sufficient strength to support it. Make sure there is a good water source and water drainage system close to the installation area. If the tub is installed in a place that does not meet the safety requirements, then any loss caused will not be covered by the warranty due to improper use by the consumer.

1) Indoor installation:

Some special requirements for indoor installation that need attention:

- During the filling and draining of water, water may spill on the ground. We strongly suggest that the tub only be installed near floor drains and on water-proof surfaces.
- There should be no items nor appliances that are easily affected or damaged by moisture or water in the immediate area around the tub. To ensure air quality and user comfort, the tub must be installed in a well-ventilated environment.
- Note: Do not install the tub on carpets or other surfaces that are easily damaged by water.

2) Outdoor installation:

The ground where tub is on must be smooth and flat with no sharp objects such as branches and stones nearby. Be sure to use the included floor mat for additional protection.

Do not expose the tub to direct sunlight for prolonged periods of time. This will shorten the service life of tub. We recommend covering the tub or placing it in a shaded area when not in use.

There should be a good water source and water drainage system near the tub.

1.2 Fill the tub with Water

Fill the tub with water using a water hose until there is sufficient water to be able to submerge your entire upper body under water. Fill the your plunge 3 inches below the outlet level. Leave enough room for your head to be fully above the water line. In most cases this would be at about 70% of the plunge pool.

Note: Overfilling the plunge pool will result in water spilling out and over the sides of the pool when you enter. Please be mindful of any electronics, power cords, outlets, etc around the plunge pool. We highly recommend starting with less water and then adding more as needed to submerge your entire upper body.

Tub Maintenance

2.1 Water Maintenance

We recommend keeping the pH value of the water in the tub between 7.2 and 7.8. A pH value outside of this range can shorten the service life of the tub and cause irritation or damage to your skin. Any damage to the tub caused by too high or low pH value will not be covered by the manufacturer's warranty. We suggest using a pH test kit to routinely test the water quality before using it.

2.2 Water Treatment

It is important to keep the water in the tub clean. The optional Chiller does come with a built-in particle filter to keep the water in the tub clean. Please see the Chiller User's Manual for usage instructions. If you are not using an external filter and water cleaner, then we suggest the following:

- Cover the tub whenever it's not in use to prevent debris or other particles from falling in.
- Replace the water in the tub every 3-5 days depending on usage, and then clean the tub with a
- clean cloth.
- The tub water can be treated and disinfected with suitable pool chemicals such as chlorine. Be sure to follow instructions on the packaging of the cleaning agents. Please consult a pool supply store for additional details before use.

Before using pool chemicals, please consult your local pool supply store for additional maintenance information. Pay close attention to and follow the chemical manufacturer's instructions. Improper use of pool cleaning chemicals resulting in damage to the pool or causing injury will not be covered by the manufacturer or the manufacturer's warranty.

It is important to test the water daily or as needed for proper pH and chemical levels. We recommend using chlorine reagents to maintain the cleanliness and chemical balance of the water. Always use chemicals sparingly and add the pool chemical to the water and never add pool chemicals to an empty tub.

Note: There are also chlorine free chemicals available. These may be a better option for those with more sensitive skin.

Warning: Let any chemical agents fully dissolve and mix into the water before using the tub. Do not exceed the manufacturer's recommended usage of chemicals and be sure to consistently test the water.

2.3 Cleaning the Tub

Dirt from the body and clothes, and contaminants in the water can easily adhere to the surface of tub. It is necessary to frequently wipe down the surface of tub with a soft cloth and a neutral detergent. A fine, soft brush can be used to gently scrub the water inlet and outlet to prevent scaling and calcification to form around the water inlet and outlet.

Note: Do not use hard bristle brushes to clean the surface of the tub.

2.4 Tub Storage

Proper care and storage will prolong the service life of the tub. Before storing the tub, completely drain all water from the tub and wipe it down clean with a soft cotton cloth or towel. It is recommended to cover the tub and store it in a cool dry place.

Note: Do not store or use the tub in an environment below zero degrees Celsius or store under direct sunlight for extended periods of time. The tub shell will fade or become brittle and shorten the overall life of the tub. Damage caused by improper storage or care will not be covered by the manufacturer's warranty.

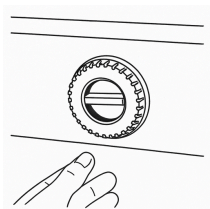
2.6 Draining your tub

- **Prepare the Area**
 - Place a towel on the floor near the plunge to catch any small amount of water that may escape during the process.
- **Locate the Drain Plugs**
 - Your plunge comes with two drain plugs. These are designed to fit into the inlet and outlet holes inside the plunge.



- **Insert the Drain Plugs**
 - Before disconnecting any hoses, insert both plugs firmly into the inlet and outlet holes inside the plunge.
 - This step prevents water from flowing back out while you drain.
- **Open and Connect Your Drain Hose**
 - Pull the drain port toward you until it is fully extended, then twist counter clockwise to open the drain and remove the cap. Once the cap is removed then you can either twist on your garden hose or if you would like to just directly drain the water onto the floor then you will turn the blue dial to the right to release the water.
 - Allow the water to flow out completely. Depending on your setup, this may take several minutes.
- **Finish Up**
 - Once drained, make sure to apply the chiller hoses back onto the plunge and remove the plugs if needed and store them in a safe place for the next use.
 - To ensure that all the water is clean in your tub, please make sure to remove all the water from your chiller as well.

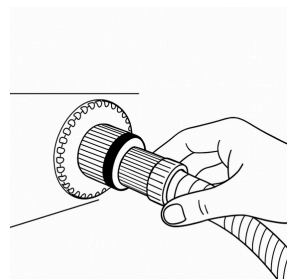
2.7 Opening your Drain on your Plunge



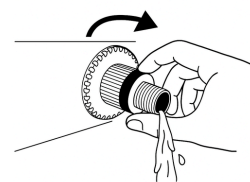
1. Pull drain plug out towards you



2. Twist the cap counter clockwise to remove cap



3. Twist on a standard garden hose to remove water in a different area



4. Twist the blue nozzle clockwise to release water

2.8 Stealth Luxe Model Only – Lighting system

1. Insert the Battery

- Slide open the battery compartment on the back of the remote.
- Insert one coin cell battery (CR2032 is recommended)
- Close the compartment securely.

2. Power On/Off

- Press the power button to turn the accent lighting on or off.

3. Select Colors & Modes

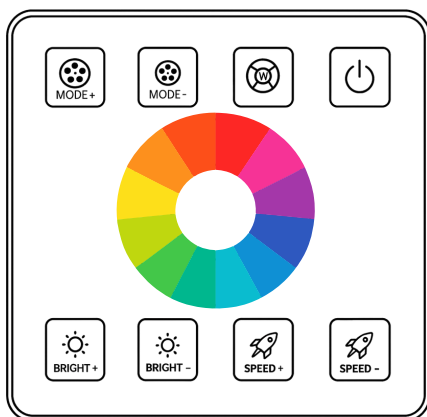
- Use the color wheel in the center to choose from a full spectrum of accent colors.
- Toggle through preset lighting modes (such as fade, strobe, or smooth) to customize your experience.
- Adjust the speed of the color changing mode with speed buttons.

4. Adjust Brightness

- Use the brightness controls (+ / -) to increase or decrease light intensity.

5. Enjoy Your Setup

- Point the remote directly at the lighting receiver for best performance.
- Your accent lighting is now ready to enhance your Stealth Luxe experience.



Warning: Hypothermia Risk in the Cold Plunge

Hypothermia is a serious condition that occurs when the body loses heat faster than it can produce it, causing the core body temperature to drop to dangerous levels. Overexposure to cold water, like in the cold plunge, can increase the risk of hypothermia. It's essential to be aware of the potential dangers and take necessary precautions to ensure your safety.

Water Temperature	Time of Exposure	Potential Symptoms	Expected Time of Survival
Above 70°F (21°C)	Prolonged	Unlikely to cause hypothermia at these temperatures.	N/A
60-70°F (15-21°C)	1-2 hours	Gradual onset of shivering, discomfort.	Negligible
50-60°F (10-15°C)	30-60 minutes	Intense shivering, numbness, reduced coordination. Dizziness may occur.	1-3 hours
40-50°F (4-10°C)	15-30 minutes	Severe shivering, confusion, loss of dexterity. Unconsciousness possible.	30 minutes - 1 hour
32-40°F (0-4°C)	15 minutes or less	Profound shivering, confusion, dizziness, poor judgment, risk of cardiac arrest. Unconsciousness likely.	15-45 minutes
Below 32°F (0°C)	Minutes to seconds	Immediate risk of cold shock, loss of breathing control, cardiac arrest. Survival unlikely.	Minutes to 15 minutes

SAFETY AND OPERATIONAL WARNINGS

- Before using this product, it is essential to read this entire manual and all instructions. This plunge tub is intended for use solely in the manner described in this manual.
- Carefully inspect your cold plunge tub upon arrival for any signs of breaks or leaks before filling it with water. Filling a unit with pre-existing damage can lead to further damage or flooding.
- It is recommended to consult a physician before beginning your cold plunge therapy regimen.
- Please do not leave children unsupervised around the tub. Extreme caution must be exercised to prevent unauthorized access by children. Always lock the tub with the included cover and locking clasps when not in use.
- Pets should be kept away from tub to avoid damage and injury.
- Never operate any electrical appliance when in the tub or when your body is wet. Do not place any electric appliances, such as lights, telephones, radios, or televisions within 5 feet (1.5m) of the tub.
- The use of alcohol, drugs, or medication before or during the cold plunge may lead to loss of consciousness with the possibility of drowning.
- Persons with a history of heart disease, low or high blood pressure, circulatory system problems, or diabetes should consult a physician before they use a Cold Plunge Tub.
- Persons using medication should consult a physician before using a tub since some medication may induce drowsiness while other medication may affect heart rate, blood pressure, and circulation.
- Prolonged immersion in water below 70°F (21°C) can pose a risk of hypothermia. Please note that the core body temperature can continue to drop even after emerging from the cold plunge tub.
- Do not operate tools or heavy machinery or attempt to drive immediately after completing a cold plunge.
- Always enter the cold plunge tub feet first and breathe continuously in a steady, structured rhythm. Do not attempt to hyperventilate or hold your breath while immersed in the tub.
- Exit the tub immediately if there are any feelings of weakness, exhaustion, or being unable to control your fingers, hands, arms, and legs.
- Regularly inspect your cold plunge tub for wear, tear, or damage. Maintain proper maintenance as specified in the User's Manual.

ASSUMPTION OF RISK ACKNOWLEDGEMENT

I further represent and warrant that to the extent I suffer from any physical or mental infirmity, chronic ailment, or injury of any nature, that I have consulted with a medical professional and received clearance to participate in the Activities, and that I recognize and assume the risk of engaging in the Activities in light of my condition.

3. Governing Law; Arbitration.
