Section 4. FIRST AID MEASURES

EYES: In case of contact with eyes, rinse immediately with plenty of water and seek medical advice.

Section 5. SPECIAL FIRE FIGHTING PROCEDURES

Extinguishing media: Water, dry chemical, CO2. Universal type foam.

Use water to keep fire-exposed containers cool and avoid increase in pressure that can cause the release of the drum lid.

High temperatures and fire conditions may cause rapid and uncontrolled polymerization, which can result in explosions and the violent rupture of storage vessels or containers. Avoid the use of a stream of water to control fires since frothing can occur.

Section 6. ACCIDENTAL RELEASE MEASURES

Spontaneous polymerization can occur. Eliminate ignition sources. Use eye and skin protection. Place leaking containers in a well-ventilated area. Dike and recover large spills. Soak up small spills with inert solids (such as vermiculite, clay) and sweep/shovel into disposal container. Wash spill area with strong detergent and water solution; rinse with water, but minimize water use during clean-up. Do not flush into sewer! US Regulations (CERCLA) require reporting spills and releases to soil, water and air in excess of reportable quantities. Section 7. STORAGE AND HANDLING

Handling: Keep containers tightly closed. Keep containers cool, dry, and away from source of ignition. Avoid prolonged exposure to light. Remove all contaminated clothing, shoes, belts and other leather goods immediately. Incinerate leather goods (including shoes). Wash contaminated clothing thoroughly before reuse. Wash skin thoroughly with soap and water after handling. Solvents should not be used to clean skin because of increased penetration potential.

Storage: Most acrylic monomers have low viscosities, thus only needing room temperature conditions to facilitate proper pouring techniques. However, viscous type gels such as these may require heating to facilitate proper pouring techniques. To ensure that this happens, product may be heated to 60°C/140°F for not more than 24 hours. Do NOT use localized heat sources such as band heaters to heat/melt product. Do NOT use steam. Hot boxes or hot rooms are recommended for heating/melting 3 materials. The hot box and/or room should only be set to a maximum temperature of 60°C/140°F. Do not overheat, this may compromise product effectiveness and should be avoided. Refrain from multiple reheating of product, this will also diminish the quality of the product. Product is extremely light sensitive. If exposed to natural light or UV light, material will cure very quickly. Store in a cool, dry place, away from heat and all types of light. Store at temperatures below 100°F/38°C but above the product's freezing point. If no freezing point is given, keep above 32°F/0°C at all times.
