ACTIVE ADVOCATE POLICY

To be eligible to receive commissions Advocates must abide by the Crunchi Advocate Policies and Procedures, Advocate Terms and Conditions, and Advocate Credo. To maintain active status, Advocates must abide by our Active Advocate Policy, which requires Advocates to purchase or sell at least \$400 in Personal Volume within a six-month rolling consecutive period and be current with the annual renewal fee of \$60.

Note: These figures do not represent an Advocate’s profit, as they do not consider expenses incurred by an Advocate in operation or promotion of their business. The figures above refer to gross income (total income before any expenses are deducted). Advocate business operational expenses may vary from several hundred to several thousand dollars annually.
