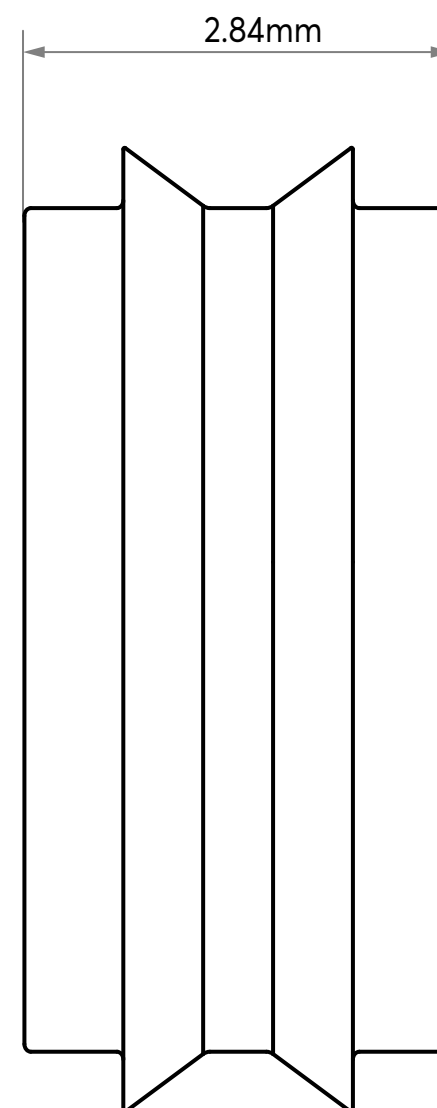
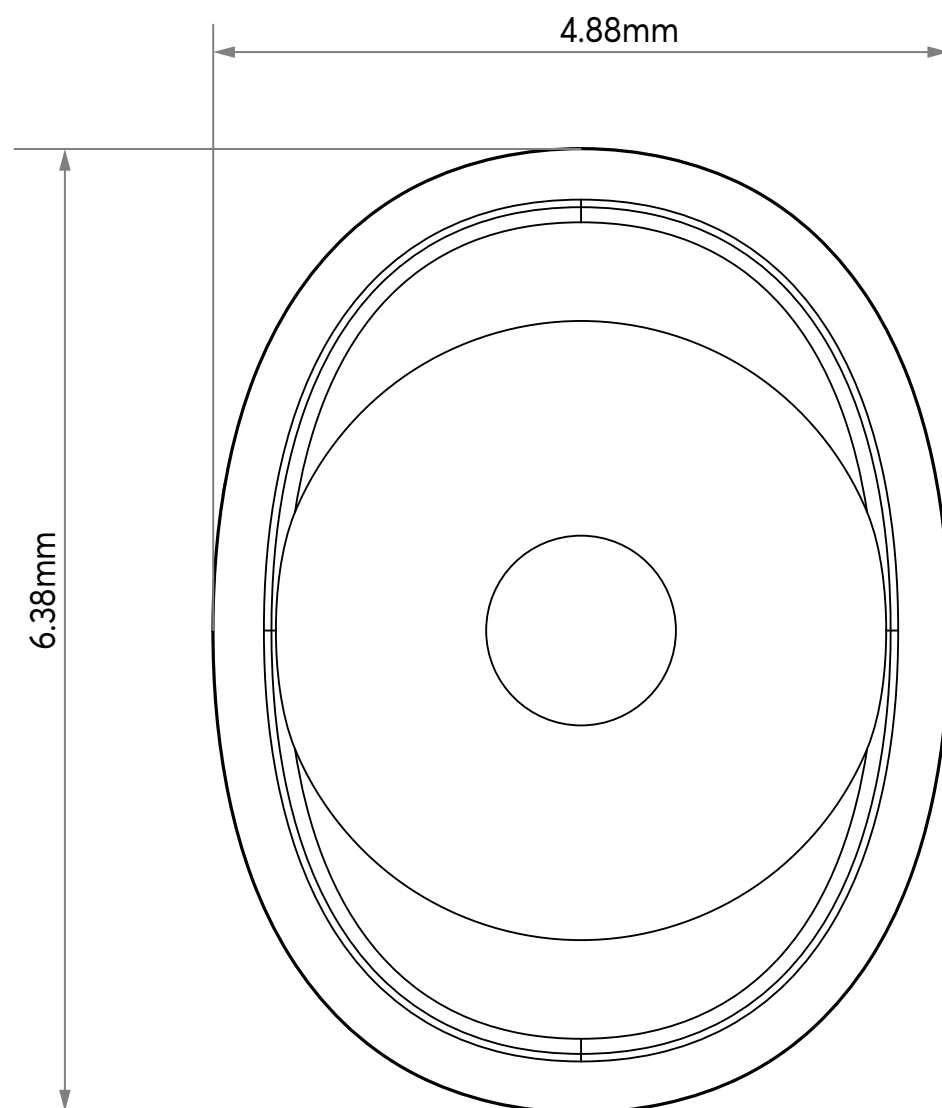


Check the inserts are sitting flat and not protruding out the end of the tip.

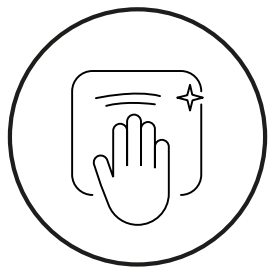

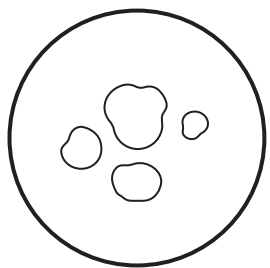
Choking hazard

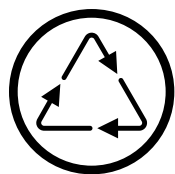

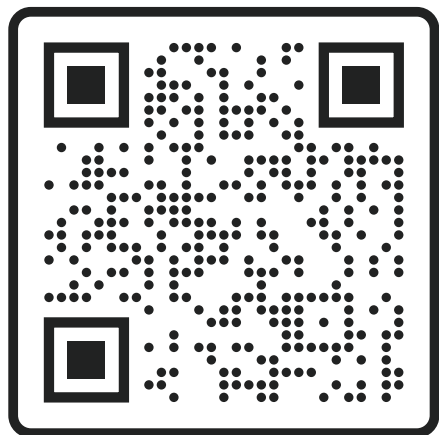
