

Isolate


Instruction Guide




Isolate comprises of a stem and a tip.




Select a suitable tip size (if you are unsure, start with the smallest tip) and attach it to the Isolate stem.



Push the tip on to Isolate leaving no gap between the tip and stem.




Pinch and roll the tip between fingers to compress the thermo-reactive memory foam tips.



Pull top of ear up and backwards to open ear canal.
Insert Isolate gently and securely into your ear.

Allow up to 10 seconds for the tip to expand and shape to your ear canal for the perfect seal.



To remove, pull top of ear up and backwards. Then twist and gently pull Isolate out of your ears.

Safety Guide

Warning: If the recommendations are not adhered to, protection afforded by the earplugs will be severely impaired. The bodies do not have a set lifespan but should be carefully maintained as per Flare recommendations. Sudden or fast removal of earplugs out of the ear canal may damage the ear drum. If a user feels uncomfortable or in pain at any point due to noise level, the user should safely leave the environment and then remove the PPE.

Please Note: To determine correct fitment, only bone conducted sound should be heard. The user should hear no direct sound coming through their ears. The earplugs should feel secure and fit well enough not to fall out or protrude beyond the outer ear.

• Keep in the sealed packet until ready to use. Store in a clean, cool and dry area away from direct sunlight and any harmful chemicals that may damage the earplugs • Once opened keep clean to avoid contamination in the mesh pouch provided. Clean and disinfect metal with warm soapy water. Clean and disinfect tips with a damp cloth and leave to dry • This product may be adversely affected by certain chemical substances. Further information should be sought from the manufacturer • This hearing protection is RE-USABLE.
